the Pilot Brunz exited the cockpit and accompanied Flight Attendant Gilbert-Blanchad to Mr. J. Baez's seat to attempt to wake him up. After several attempts J. Baez finally woke up and he was advised that he will not be able to fly on that flight due to his condition and was requested to depart the aircraft.

As the pilot and flight attendant was escorting J. Baez toward the exit door his brother Defendants L. Baez decided to also depart the aircraft as he wanted to stay with his brother. As they were both walking toward the door both defendants became extremely belligerent toward the Flight Attendants and the Pilot. Mr. L. Baez stated to the pilot when you fly to San Juan I will have you killed. Both Defendants departed the aircraft while the Pilot stayed on the aircraft. Shortly after departing the aircraft J. Baez reentered the aircraft and struck the pilot, with a closed fist, in the face causing a large bruise, lacerations, and causing blurred vision to his left eye, all resulting in possibly permanent damage. Flight Attendant G. Smith attempted to intervene and defuse the situation at which time Mr. J. Baez struck her on her right shoulder. While both defendants' were walking on the jet bridge toward the Terminal the Pilot was behind them to assure that they exited the jet-bridge door. Prior to the defendants' exiting the jet-bridge they both conspired to attack the Pilot and both jumped him and started beating him with closed fist throughout his body and chest area and chased the Pilot into the Terminal where they continued to beat him.

Both Defendants were detained by fellow flight crew members and passengers of the flight who rendered aid and prevented the defendants from fleeing the area. Both defendants were taken into custody and were transported to D.C.J. via MDPD Station 7 for processing.
